

SPRINGER INSTRUCTIONS FOR AUTHORS

Author can choose to work with MS Word or Latex. You can find the templates here in the folders **Latex2e+Proceedings+Template** and **Microsoft+Word+Proceedings+Templates**.

Please prepare your chapter in **one-column format**.

Please add **under the title** the **authors' names, institution, country, city, country** (*no street or any other address part – neither a complete private address - should be added there*, as this will show up on our webpage). Please check the sample paper in the Latex package in this folder.

Each chapter should begin with a **one-paragraph** abstract that summarizes its content in no more than 200 words in plain text. The abstract will appear online at SpringerLink and be available with unrestricted access to facilitate online searching, using e.g. Google, and allow unregistered users to read the abstract as a teaser for the complete chapter.

For authors working with Word: please avoid inserting equations as graphic files. Use the Math function of Word 2003 or 2007, MathType or Microsoft Equation Editor to create your equations.

Please include all affiliations and e-mail addresses (or at least the email address of the corresponding author) in the chapter you submit to the book editors. The e-mail addresses will be used by SpringerNature to provide authors with a personal account where they can download a free copy of the eBook upon publication.

Permissions for any material authors want to reuse from previous publication should be obtained by the corresponding publisher they want to reuse. Usually, authors can GET PERMISSION online by using RightsLink <http://www.copyright.com/publishers/rightslink-scientific/>. In rare cases, they need to contact the publisher directly. Moreover, Springer is a STM signatory publisher. If authors wish to reuse materials published by another signatory publisher, they can check the corresponding guideline for permission at <https://www.stm-assoc.org/intellectual-property/permissions/permissions-guidelines/>

Springer self-archiving policy for non-open access book and chapters can be found at <https://www.springernature.com/gp/open-research/policies/book-policies> . Because this book is NOT an open access one, please check the policies for self-archiving of books and chapters published via the subscription route. Archiving of pre-print on a recognized server, up to one chapter per volume from the same author, is allowed for proceedings.

Your Final Submission should include:

1. PDF of the accepted paper (only the final version, please remove any older version and correction marks).
2. Word or Latex source files (a .docx file for Word, a .zip archive for latex).
3. If any, bib and image files (please include them too, even if images are included in the Word file: we may need original graphics files of all figures). Please remove any older file / alternative version.
4. Signed License to Publish (LTP). Please be sure that **EXACTLY** the same information (authors name and order, corresponding author detail) is shown on the license and on the paper. Please also make sure that the Corresponding Author Name on the first page of LTP **exactly matches** the Signing Author Name on the last page (otherwise your paper will not be published). Please sign the license per hand and scan it / save it as PDF. All pages should be scanned and saved in one document.
5. ALT TEXT – please check the attached presentation (“how to write good alt text” and the sample excel file ALT_Text_submission_example), then use this sample as a template to prepare Alt Text for every figure in your manuscript.

Additional remarks from the Editor

For the **initial submission**, it is sufficient to enter the metadata and upload a PDF. If accepted, you will be required to prepare a final version of your chapter, including all required components, and upload them to a different location in EasyChair, as you will be instructed in the notification letter.

Please pay attention that the first name should be spelled out completely: entering an initial is not sufficient. Middle initial is optional.

In this book – and throughout the English literature – the first name of the author goes first, and the last name goes last, not vice versa (example: **Olga Sysoeva, not Sysoeva Olga**). If you fail to follow this order exactly and consistently in the metadata and in the paper itself, then your paper may not be published, and for sure will not be indexed properly.
